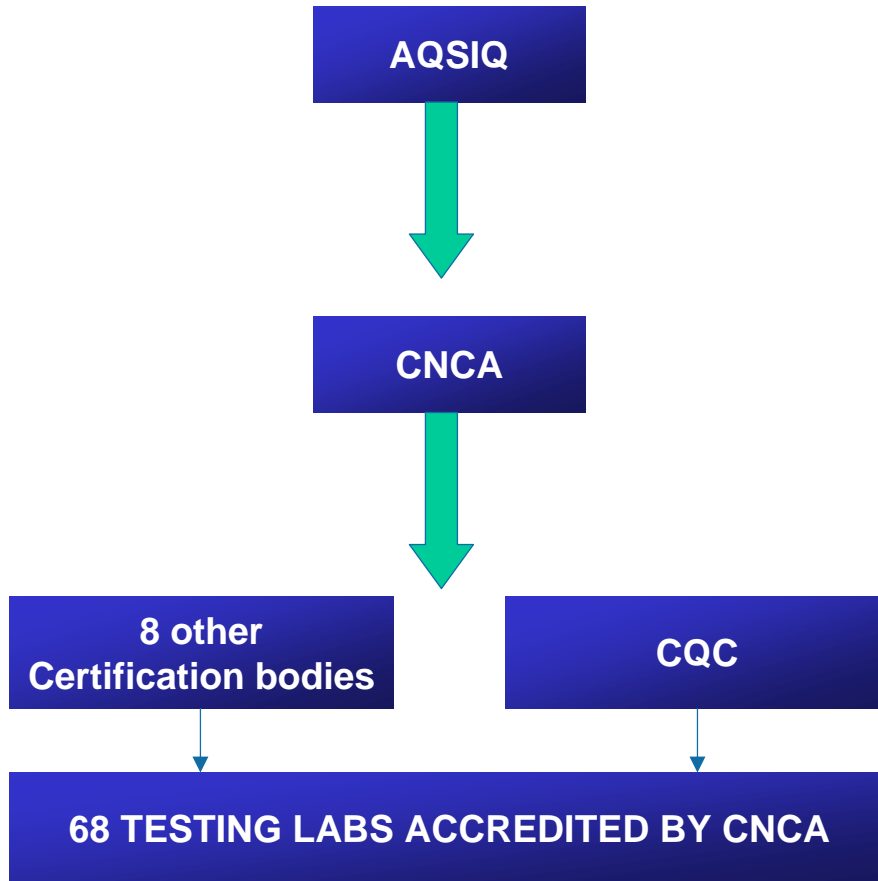

## CCC Adoption Timeline

**April 30, 2002**

Prior to this date products subjected to the old CCIB/CCEE system

**May 1, 2002**

New system (CCC) implemented – applications under old system no longer accepted

**April 30, 2003**

Prior to this date products subjected to the old CCIB/CCEE system or new system can be marketed or imported

**May 1, 2003**

Old system annulled

Products subjected to the new system, domestic and imported must have CCC certification mark applied





## China's Previous System

### CCIB Mark

Safety license mark, first put in place in 1989, with 9 product categories, expanded to 47 product categories in 1996/1997

### Great Wall or CCEE Mark

Electrical safety license mark, put in place in late 1990s, with seven product categories.



# International Approvals – China Compulsory Certification (CCC)



## □ Prior two-mark system

- Redundant, burdensome, and not WTO compliant
- Some imports needed both marks; Some domestic products required less burdensome or no licensing

## □ WTO Rules

- For all mandatory standards and testing rules, a country must ensure:
  - National Treatment - domestic products and imports must be treated the same
  - Transparency - publication and availability of laws, regulations, and mandatory standards

## The Good News

- ❑ Transparency now required by WTO
  - ❑ Detailed technical regulations are public
  - ❑ The public can comment on new rules
  - ❑ A WTO National Enquiry Point fields enquiries
- ❑ A level playing field with domestic goods
- ❑ Redundancies have been reduced
  - Some still exist, e.g. medical devices and IT/telecom
- ❑ Trade barriers can now be addressed at WTO
- ❑ WTO pushes China toward internationalization of standards and testing





## The Bad News

- ❑ **Still some of the most burdensome rules of any major trading nation**
  - In-country testing; factory inspections
- ❑ **Redundancies remain**
- ❑ **Chinese Regulatory Practices**
  - Vague regulations
  - Reliance on dialogue between testers or regulators and applicants, instead of specific written rules
  - Local regulators or customs officials have great autonomy

Only safety - core mark with S (small capital letter) in right corner

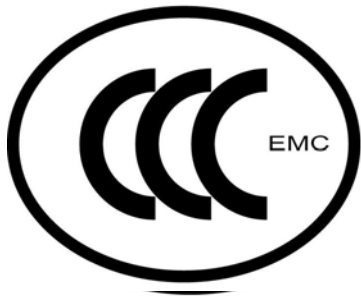
Safety + EMC - core mark with S&E in right corner





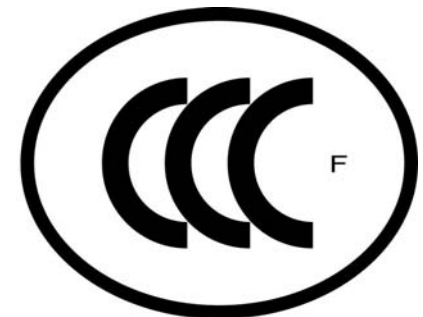

According to the approval, the following letters will be added to the core design



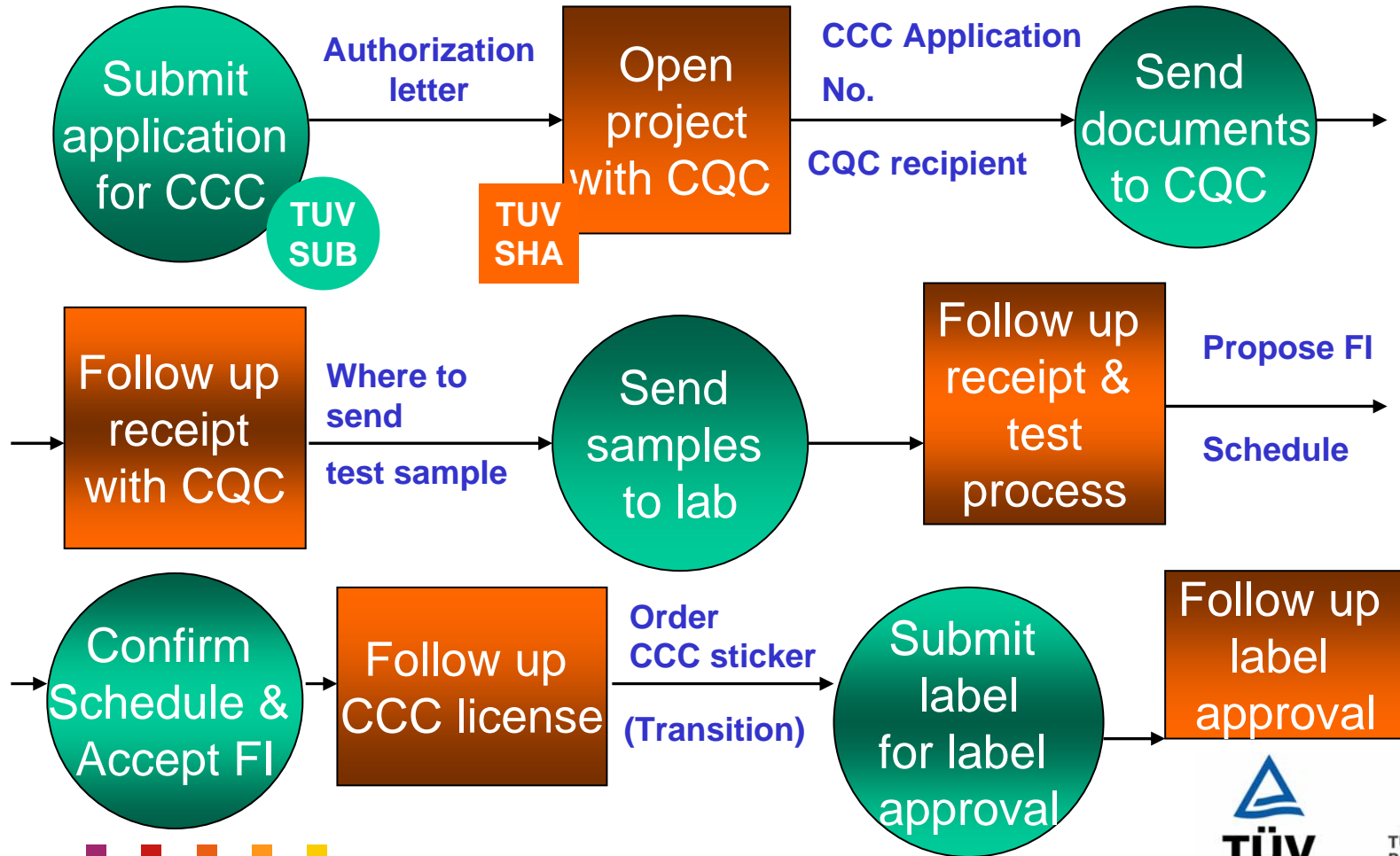
**EMC - core mark with E (small capital letter) in right corner**

**Applies for fire warning and fighting appliances**





## General Procedure (example categories 7 and 8)





## Documentation Required (example categories 7 and 8)

- Authorization letter/ Application letter.
- Where available - CB test report which addresses applicable Chinese National Deviations (rated voltage 220V ± 10%).
- Declaration of conformity complying to relevant GB Standards.
- Critical component lists related to safety and EMC
- Description of the difference between the different model/type of products in the same application.
- Service manual or user's manual in Chinese.
- Nameplate and warnings in Chinese.
- Circuit diagrams and/or system block diagrams.
- Electronic copy of photo documentation.
- Questionnaire for initial FI or the latest FI report

### Samples Required (example categories 7 and 8)

- ❑ Two samples
- ❑ One for EMC Testing
- ❑ One for safety
- ❑ Required regardless of testing already conducted

### Typical Costs (example categories 7 and 8)

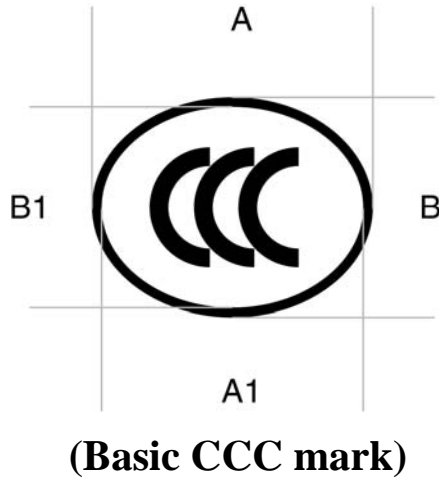

## CCC Mark on the product



In transitional period after getting CCC license, Order to CNCA for CCC black/white sticker:

A = 8mm (US\$42 / 5000 pcs/min package)

A = 15mm (US\$76 / 4500 pcs/min package)

A = 30mm (US\$51 / 1500 pcs/min package)

A = 45mm (US\$27 / 450 pcs/min package)

A = 60mm (US\$30 / 450 pcs/min package)

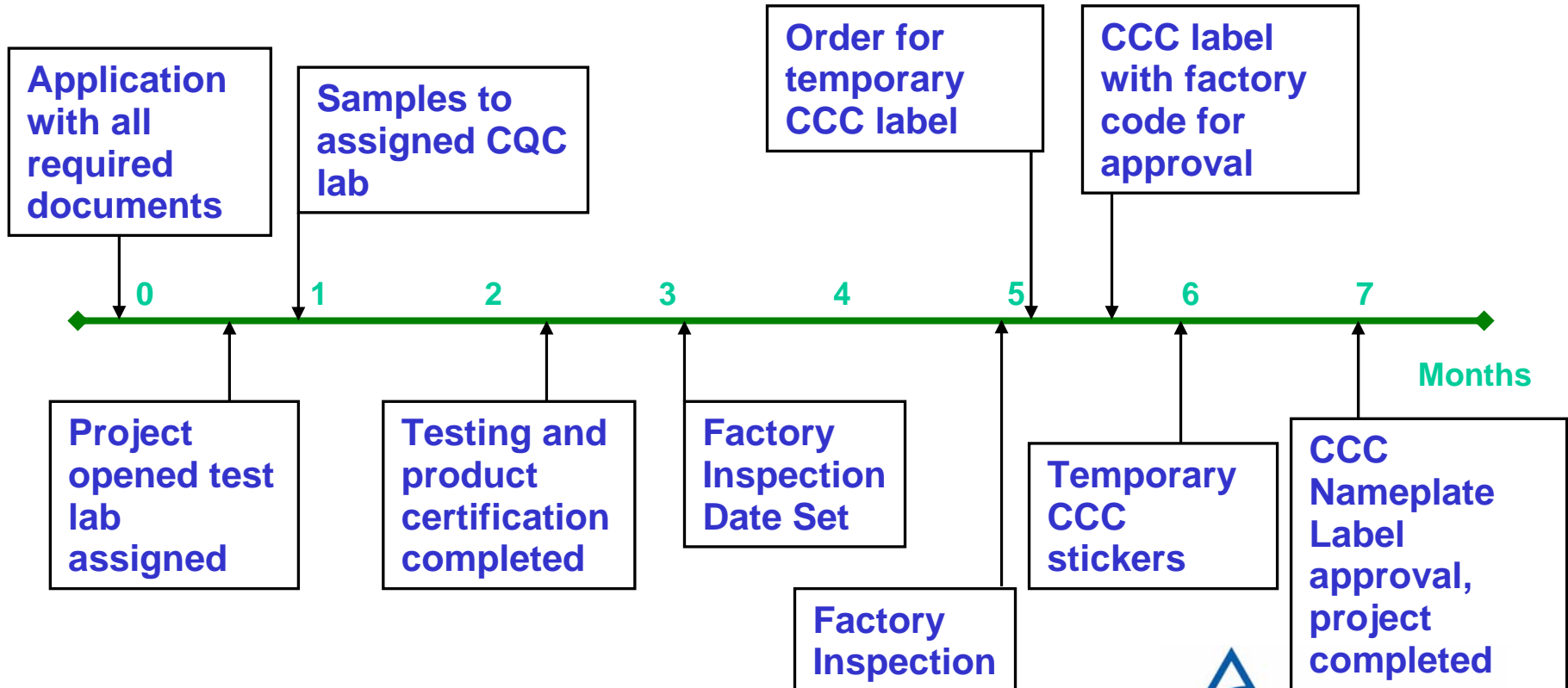
Applying for nameplate approval, Submit to CNCA 10 samples of nameplate with required CCC mark and CCC license No (factory code) under the mark

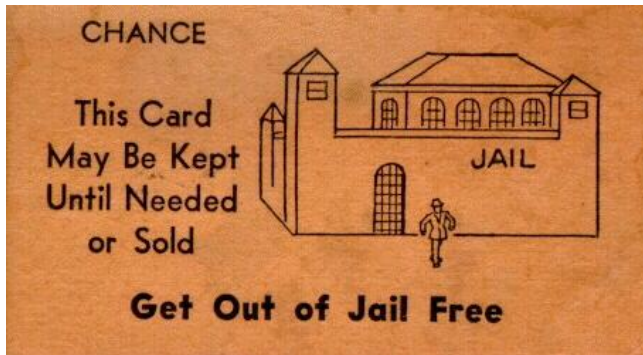
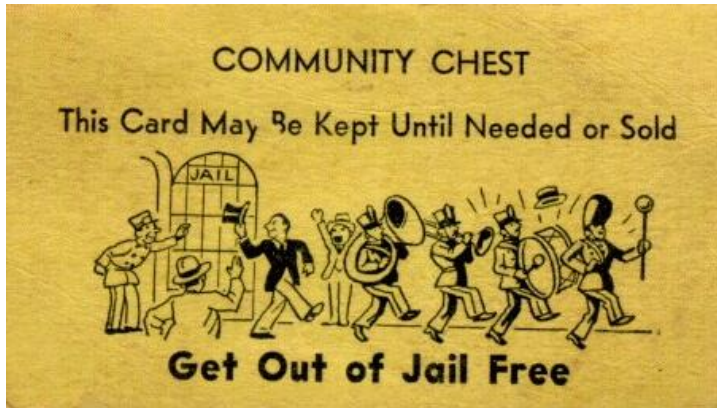

## CCC Exemptions



- ❑ Possible to obtain for certain conditions
  - ❑ Products/components for re-export
  - ❑ Products not placed on the market
  - ❑ Products used in a manufacturing facility
  - ❑ Exemptions completed in China by local representative
- ❑ Not required to complete exemption if product not on First Catalog
- ❑ US DOC – Monthly filing
- ❑ US DOC – Process Not finalized





## CCC Pitfalls

- ❑ **Commitment to the Market**
  - ❑ **Realistic expectations**
  - ❑ **Long-run not short term**
- ❑ **Localization time**
  - ❑ **Product 220V, 50Hz**
  - ❑ **Manuals/Markings**
  - ❑ **Software**
  - ❑ **User Interface**
- ❑ **Non-compliant product provided for testing**





## Typical CCC Agent service

- Testing evaluation/CB report to applicable standard
- Handling and proceeding the formal/legal application with the relevant government agency .
- Providing assistance with the documentation review process.
- Arranging the sample testing with the appointed localized laboratory.
- Coordinating the auditing of the production facility
- Facilitating the issuance of the applicable certificate
- Executing the mandatory marking requirement application
